# UN Commission on International Trade Law, Working Group V - Breakfast Panel April 21, 2014 Jones Day, New York, NY

On April 21<sup>st</sup>, IWIRC NY hosted an exceptional breakfast panel featuring delegates of the <u>UN</u> <u>Commission on International Trade Law</u>, Working Group V, including <u>Christopher Redmond</u>, <u>Irit</u> <u>Mevorach</u>, <u>Jenny Clift</u>, <u>Riz Mokal</u>, Caroline Moran and the Honorable <u>Elizabeth Stong</u>, moderated by IWIRC NY Board Co-Chair <u>Carren Shulman</u>.

During breakfast, we learned how the member states and nongovernmental organizations (NGOs) have worked together over the years to address cross-border insolvency issues. In particular, the delegates discussed the role of the Secretariat and the consensus-building manner in which the various constituencies develop and refine the Model Laws, Legislative Guide, and Practice Guide on Cross-Border Insolvency.

IWIRC has been recognized as an NGO since the mid-1990's, thanks to the invaluable assistance of the I Honorable Burton R. Lifland, U.S. Bankruptcy Judge for the Southern District of New York, and selected IWIRC members who regularly attend the Working Group V sessions. IWIRC actively participates and regularly contributes modifications to current texts and makes recommendations for future work.

#### TIPS

Each month we feature 5 TIPS on how to do something just a little bit better! This month, **Tips for Successful Negotiation– B**y <u>Jen O'Neil</u>

Listen: An underrated and under-utilized skill in today's fast paced and demanding world. Don't assume what others are saying or positions they will take. Listen attentively to show respect and build trust. Repeat the main points back to be sure you listened well and understand what's on (and not on) the table.

**Everybody Wins:** No really, go into the negotiation thinking not only what it takes for you to win, but what it might take to get to a global best case outcome. Understand others' perspectives and work to make them feel satisfied by meeting their basic interests. Going for the win-win may illuminate leverage points you would otherwise miss.

<u>Acknowledge Counter Positions</u>: Everyone wants to feel important, so acknowledge every counter and objection coming at you. Acknowledging these positions doesn't mean you have to give in to them. Sometimes people just want to be heard and understood and have a lot more flexibility than they initially present with.

**Be Aware:** Be prepared and get as smart as possible on the situation, which includes playing the emotional dynamic as much as the substantive one. Think about <u>who you're dealing with</u> and how to best negotiate with them and their emotions. The process isn't always, and certainly doesn't have to be, logical and rational.

<u>Be Ready to Walk Away</u>: Walk in ready to walk away from a negotiation. This sends a strong signal that you believe your position is fair and you are willing to risk not reaching an agreement instead of compromising on your most important points. The trick is to use this tool wisely - it should be a business decision, not an emotional reaction.




