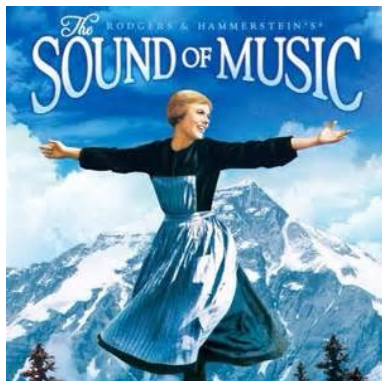

An Informal Conversation with the Clerk of the United States Bankruptcy Court for the District of Delaware

Tell us about your career path to the federal courts?

I became interested in bankruptcy law in law school due primarily to Professor Karen Gross who made the subject fascinating. I worked as her research assistant and then got an internship in the New York Southern Bankruptcy Court with Chief Judge Burton Lifland. By then I was hooked on both the area of law and working in the court. Upon graduation I had a two year clerkship with Judge Tina Brozman (Judge Lifland had already filled his clerk position!). It was the early 1990's and the court was extremely busy. I left the court to join Weil Gotshal & Manges in the Corporate Restructuring Department. I loved the work and my colleagues but after a time there I wanted more of a personal life. Chief Judge Lifland asked me to return as his career law clerk where I remained for several years. In addition to his case load, he was a delegate to the United Nations and I worked with him on the UNCITRAL Model Law and the drafting of chapter 15; with the International Monetary Fund on a proposed Sovereign Debt Restructuring Mechanism and several other initiatives. In 2009, I became the Chief Deputy in that court.

How do you like Delaware?

I am still learning my way around the area but I have received a tremendously warm welcome here. It does seem like everyone knows everyone else - a nice small town atmosphere! And I love driving to work instead of commuting to NYC!

What do you like to do in your free time?

Golf, garden, hike, read, socialize with friends and family .

What do you know now, that you wish you knew earlier in your career?

How quickly time goes by.

How were you empowered to grow professionally, and who encouraged you?

My most important person is my mom who believed there was nothing we couldn't do if we tried.


