Laura Bouyea (Venable)

Starting with this issue, the newsletter will include a member spotlight each month. The inaugural "Member Spotlight" member is **Laura Bouyea** (Venable), the Greater Maryland Network's immediate past co-chair.

Proudest professional moment: My proudest professional moment was being offered a position as an associate in Venable's Bankruptcy and Creditors' Rights Group because I knew that there would

be no better springboard for my legal career. I was correct. In the 13 years since I joined the firm, I have had the opportunity to touch almost every aspect of bankruptcy, representing debtors, secured and unsecured creditors, creditors' committees, bankruptcy trustees and liquidating agents in all aspects of bankruptcy. Venable also has been very supportive of my pro bono and volunteer work, which includes involvement in the House of Ruth, the Maryland Food Bank, My Sister's Place Women's Center, and V-LINC, a non-profit organization serving people with disabilities.

Biggest professional hurdle: The annual decline in business bankruptcy filings since 2009 has certainly been a challenge. The decline in filings quickly made it apparent that it would make sense to supplement my bankruptcy work with a state court creditors' rights practice. This ended up being a blessing in disguise, as this has since provided the opportunity to litigate in state courts across the country. My focus in state court has been on single asset real estate and has included commercial foreclosures and receiverships, lender liability actions and guaranty actions.

Work history: After graduating from the University of Richmond and before starting law school, I spent one year working for Arthur Andersen as an auditor. I sat for and passed the CPA exam during this time and was able to gain exposure to the retail, manufacturing, service and healthcare industries as well as to state and local government. While attending law school, I worked for Deutsche Bank in their mutual fund compliance group with a focus on the Investment Company Act of 1940. After law school, I clerked for the Honorable James F. Schneider, the then Chief Judge of the United States Bankruptcy Court for the District of Maryland, for two years. I then joined Venable where I've been for the past 13 years.

Favorite pastime(s): I love volunteering in the community and spending time with my family including my husband, Mike, and our three children, Abby (11), Hayden (9) and Brennan (9 months). I relive my own days in Girl Scouts as the leader of Abby's Junior Girl Scout Troop. I also try to find a little time to exercise myself, completing 1-2 triathlons in each of the last 5 years. Our family loves to explore new cities and to relax lakeside in North Hero, Vermont and Lake Placid, New York. We are trying to decide which of the 46 peaks of the Adirondacks we should try to conquer as a family this summer.

One thing my other IWIRC members don't know about me: I grew up a diehard sports fan and grew up attending playoff baseball and football, the Olympics, the NCAA basketball tournament, college football bowl games, and the World Figure Skating Championships. My favorites were the last baseball game to be played at Memorial Stadium, the first baseball game to be played at Camden Yards, Cal Ripken's last game and the finals of the women's gymnastics team competition at the 1996 Summer Olympics (Kerry Strug's famous vault to clinch the gold for the United States).
