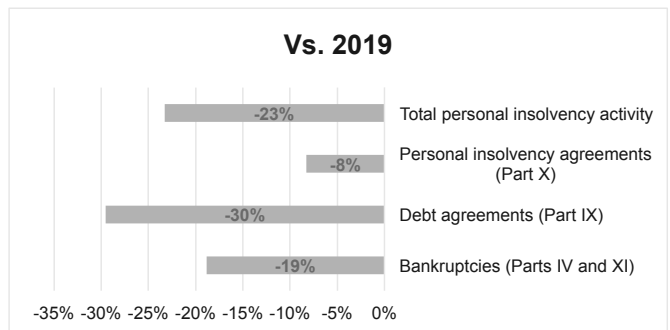
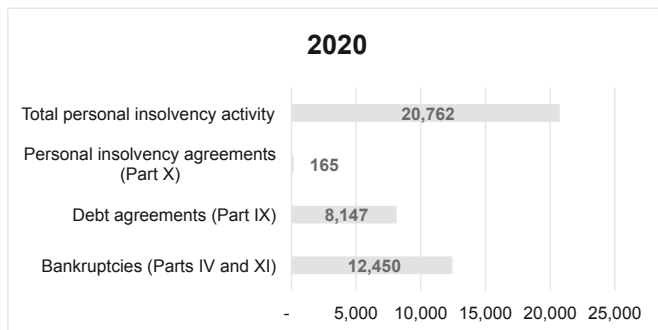
# The Impact of Covid-19 in the Insolvency World: A Global Perspective
