#### New Jersey and Greater Philadelphia Networks

IWIRC New Jersey and IWIRC Greater Philadelphia held a joint networking event on September 28, 2022, at the Grounds For Sculpture and Rat's Restaurant in Hamilton, NJ.

Founded by artist and philanthropist Seward Johnson, the Grounds For Sculpture features nearly 300



Additionally, on March 2nd, 2023, IWIRC Mexico and REDD Intelligence hosted an event at the Four Sesons Hotel Mexico City where the subject matter was "Legal Actions foreseen in the Mexican Bankruptcy Law comparable to the Automatic Stay," a legal figure that temporarily prevents creditors, collection agencies, governmental entities, and others from pursuing debtors for the money they owe.
