Network News


Scotland Network

British Virgin Islands Network

The BVI Network hosted a complimentary technical event on 9 September 2024 for its members and guests generously supported by sponsor organisation, Wilberforce Chambers.

Tara Taylor of Wilberforce, a chancery barrister who focuses on civil fraud, insolvency, shareholder disputes and offshore work provided an insightful overview of the recent mammoth 533-page judgment (Re BHS Group Ltd [2024] EWHC 1417 (Ch)) in the misfeasance and wrongful trading claims brought against the directors of the failed retailer. The decision follows on from the earlier ground-breaking decision in Sequana (BTI 2014 LLC (Appellant) v Sequana SA and others (Respondents) [2022] UKSC 25) and provides further judicial guidance on the required standard expected from company directors.

Jenni Jenkins, a litigation partner of Mourant (BVI) and also an IWIRC BVI board member gave some tips and tricks on asset recovery and enforcement of claims. Members enjoyed her highly personalised content on lessons learned and in particular were regaled with a very amusing story about her own personal efforts to obtain possession of a rug which the



vendor stupidly attempted to fail to deliver to her. Suffice to say, the fraudster was no match for this international asset recovery specialist!

Finally, they enjoyed a comparative overview of Receivership options from Kesha Adonis of Maples (BVI). Kesha used her significant experience to offer insights on the various pros and cons of in-court versus out of court receivership appointments.

The event was well supported with over 60 attendees enjoying the drinks and canapes and networking opportunities, following the long Summer vacation and just ahead of the start of the new legal year.

Europe Network Hosts Insightful Panel on UNCITRAL Working Group V at Dublin International Disputes Week

During the recent Dublin International Disputes Week, the Europe Network hosted a compelling side event at the Museum of Literature Ireland, generously sponsored by Maples and Calder (Ireland) LLP. The panel discussion focused on the work of UNCITRAL Working Group V (WGV) and featured distinguished speakers Kathlene Burke, Maples (IWIRC Europe), Debby Lim, Dentons (IWIRC Singapore), Olya Antle, Cooley (IWIRC Virginia), and Louise Brittain, Azets (IWIRC London).

Kathlene Burke, co-chair of the Europe Network, opened the session by introducing IWIRC as one of the few non-governmental organizations permitted to send a delegation to the United Nations for UNCITRAL WGV discussions. Olya Antle then provided an overview of UNCITRAL, its organizational structure, and the specific focus of Working Group V on insolvency law. She then introduced the two current projects before WG V, International Civil Asset Tracing and Conflict of Laws. The panel delved into a lively conversation on these two projects, with Louise Brittain providing an in-depth look at the asset tracing project, highlighting its background and current progress. The discussion then shifted to the conflicts of law project, with Debby Lim exploring the complexities and contentious issues surrounding the applicable law in international insolvency proceedings. The

panellists discussed the differing approaches to asset tracing and insolvency proceedings in the US, the UK, the EU and Singapore. The panellists agreed that that asset tracing project could come to a close rather quickly, but further discussions are needed to address the complexities of an international conflicts of law model law. The event was a testament to the collaborative efforts of IWIRC members across the globe and highlighted the importance of continued dialogue and development in the field of international insolvency law.

On October 10, 2024, WIR, IWIRC and III hosted a highly informative and engaging virtual conference titled "Evolutions récentes en matière de restructuration et d'insolvabilité : leçons tirées du droit et de la pratique des Etats-Unis. (Recent Developments in Restructuring and Insolvency: Lessons from US law and practice)". The conference brought together leading US, French and European restructuring professionals to discuss in-court and outof-court trends in insolvency and restructuring. Over 100 attendees joined them with live translation in both French and English.

The first panel on in-court restructurings, moderated by Hélène Bourbouloux, and featuring Judge Elizabeth Stong, Evan Zucker, Patrick Coupeaud, Agnès Piniot and Laure Sanchez-Sepval, delved into cross class cramdown, class composition and valuation disputes. The second panel on out-of-court transactions, moderated by Mylène Boché-Robinet and featuring Kathlene Burke, Fabienne Beuzit, Patrick Sayer, Molly Jobe and Marie-Hélène Monsèrié-Bon, explored the trend of Liability Management Exercises in a European context, directors' duties and French alternatives like the modat ad hoc and conciliation proceedings.

The conference provided a platform for in-depth discussions on the latest developments in French restructuring and transcended language barriers with live translation services. Over 100 restructuring professionals listened in both English and French. As European restructurings continue to evolve, IWIRC remains committed to fostering knowledge exchange and professional growth among its members.

The seminar and networking drinks were graced by over 60 members and friends of IWIRC.




Hong Kong Network
