Communications

Summer 2019

The Communications team has continued to stay busy creating and sharing content.

- **Social Media:** we plan to continue to promote our social media presence.
 - Content: as we prepare for the Leadership Summit in New Orleans and the Fall Conference in Washington, D.C., we plan to promote the programs and highlight fun facts about the cities and local networks.
 - o **Policy:** we drafted a social media policy that we hope can guide what and how we post to the IWIRC International social media accounts. We are still working through the policy, including addressing some of the initial feedback from the Spring meeting, and plan to edit it this summer so that it may be used broadly across networks.
 - Postings: to make sharing easier on the Communications Team and IWIRC staff, we want to automate postings so that we can create a series of posts at once to go live over the course of several days/weeks. We will work on how to do this and incorporate this in the Social Media Policy (above) this summer.

Website

- o **Review:** we solicited volunteers to review the IWIRC website and provide constructive feedback on it. We asked these volunteers to spend time looking at the website and generate a list of items that could be improved. We created a master list of issues/areas for improvement and have discussed the same with Shari. We plan to schedule a call with the webmaster soon to follow-up on outstanding issues.
- Policy: as with social media, we want to create a manual for keeping the website up to date. For example, we could implement a policy to review the website every certain number of days/months for certain information. We would like the E-board to be involved in the process.
- Communications survey: we recently reviewed the statistics regarding our quarterly newsletter, and they are bleak (e.g., not a lot of readership). As the Newsletter Editor spends considerable time creating a thorough and impressive project that very few members read, it seems the time has come to consider

how we share news with the IWIRC community. We suggest sending a survey to members to solicit feedback to better structure the newsletter and social media (for example, perhaps we should retain the quarterly newsletter but make it much shorter). Here are sample questions:

- Do you read the IWIRC Newsletter?
- If yes, what is your favorite feature?
- If no, why not?

 - o Other
- Would you prefer a shorter Newsletter?
- How would you prefer to receive the Newsletter/announcements from IWIRC?
- What do you think IWIRC could be doing better in terms of communications?
 Are there things you would like to see? Or things you see other organizations doing you think IWIRC should?

Going forward, we hope to continue to build on the momentum we have created and to implement a social media policy and guidelines related to the website we can use for years to come. We are always looking for volunteers who want to help our committee -- let us know if you want to join us!

IWIRC had 4 representatives this year at the meeting of UNCITRAL Working Group V on Insolvency (WGV). Kat Burke, Judy Elkin, Debra Grassgreen and Carren Shulman were in attendance for us.

WGV completed the text of the new model law on enterprise group bankruptcies. If approved by UNCITRAL's full body in July - which we believe will occur - the member nations will consider adopting it. If adopted, multinational companies can file bankruptcy in one country and have the court in that country manage the case worldwide for all related entities outside the country. While the US courts have done this in part on occasion informally, working with foreign courts, this new law would mean that one court could rule on distributions to foreign creditors of foreign companies that participate in the single workout. The goal is to streamline and speed up the process and improve communication among courts and creditors. Over 40 nations adopted the original model law in the last 20 years. UNCITRAL plans to issue an explanation of how this law would work with existing law to encourage countries to adopt it.

WGV also worked on proposed legislation by the World Bank on workouts of micro, small and medium companies. This law is just now being developed and the World Bank was holding meetings this week to improve upon the existing proposal.

Summary of oral report for Friday:

- The working group continued its work on MSMEs. A recommendation was made to delete sections 281-283 and instead include a rebuttable presumption for the exclusion of certain assets. It was also recommended to WG I that a draft guide on MSMEs consider recommending domestic law clearly delineate between personal and company assets.
- Proposals for future work were put forward by the EU and the US delegations.
- The EU proposed harmonizing applicable law in CB proceedings. The EU proposal received wide support but the work may be more appropriate for the Hague, UNCITRAL, and the EU. Any future work should be coordinated with those bodies. Also, more research may be needed on domestic practices for harmonization of laws.
- The US proposed a colloquium to commence work on a model legislative provisions on civil asset tracing and recovery. It was noted that it could be difficult to delineate criminal law and other areas of the law (i.e. family law) from insolvency law related to asset tracing. It was felt that holding a colloquium was advisable and such colloquium could also address choice of law issues and cryptocurrency.
- It was noted in the 54th session that a note for use in technical assistance activities on enterprise groups and judgements had been requested and approval was not needed for WG V.

Brief Summary

The IWIRC delegation attended UNCITRAL Working Group V (Insolvency) meetings this past week at UN Headquarters in NY. At its 55th session, the Working Group completed its work on the Draft Guide to Enactment of the Model Law on Enterprise Groups and began its work on Micro, Small and Medium-Sized Enterprises (MSMEs) Insolvencies. While it still has a long way to go, much progress was made in tailoring the recommendations for MSME insolvencies. The Working Group also entertained a proposal by the EU on harmonising the law in insolvency proceedings regarding choice of law provisions and a proposal by the USA on international asset tracing. The Draft Guide to Enactment of the Model Law on Enterprise Groups and each of the proposals for future work will be presented to UNCITRAL this July for approvals.

II. Action Items

A. <u>Maintain Membership/Attract New Members</u>

1. Outreach

The Committee will follow up with people whose IWIRC membership has recently expired. The goal is to get these people to renew their membership or understand why they have decided not to renew their IWIRC membership.

2. *Membership Survey*

The Committee has begun an outreach campaign to all of the networks with respect to the following questions:

- 1. Has your network held any events that were specifically targeted at increasing membership?
 - If yes, please describe the event.
 - Did the event result in an increase in membership numbers?
- 2. Have any of the events held by your network resulted in an increase in membership, whether or not they were targeted at that goal?
- 3. Has your network implemented any targeted strategies for increasing membership?
 - If so, please detail the strategies (e.g. price differentials for members vs nonmembers at event, specific events only for members, etc.).
 - Have these strategies have been successful?
- 4. Has your network implemented any targeted strategies for increasing diversity (race, language, LGBTQ+, age, career background, male members) of your membership?
 - If so, please detail the strategies.
 - Have these strategies have been successful?

Each committee member has been assigned networks to personally follow up with. Once the Committee has completed gathering the data, which is anticipated to be mid-June, the Committee intends to analyze the data and discuss next steps forward. The goals of the outreach are (i) to better understand how the networks are trying to increase membership and diversity; (ii) what actions are working and (iii) to share that information with all of the networks, including through an article that the Committee intends to write for the IWIRC newsletter and via content for IWIRC social media.

B. Spring Meeting

1. *ABI Spring Conference Invites*

The Committee sent an email to all women registered for the ABI Spring Conference who were not registered for the IWIRC Spring Meeting to (i) ensure that they knew about the IWIRC Spring Meeting and (ii) encouraging them to attend. This resulted in 10 additional women signing up for the IWIRC Spring Meeting. The Committee intends to ensure that a similar email is sent with respect to NCBJ and the Fall IWIRC Meeting.

2. New Member Cocktail Party

The Committee hosted a cocktail party for new IWIRC members before the opening IWIRC reception. The event was held from 4:00 pm to 5:15 pm at the Flight Wine Bar located at 777 6th Street NW, Washington, DC 20001. Approximately 25 women attended the event. The Committee received positive feedback about the location (which was a two block walk to the opening reception) and the fact that we had the whole restaurant to ourselves for the event (the restaurant agreed to open early for the cocktail party).

3. Plus One Event

Only two people registered as plus one- a spouse and a speaker. As such, there was no one for the Committee to follow up with after the IWIRC Spring Meeting. Since attendees can now register for parts of the Spring and Fall Meeting separately, the Committee does not believe that the Plus One Program is needed and has decided to suspend this effort.

C. <u>Fall IWIRC Meeting</u>

The Committee intends to begin working on the Fall New Member Cocktail Party in September. Also, the Committee intends to work with national to ensure that attendees can register for the Fall IWIRC conference which includes IWIRC membership in the price.

IWIRC Asia: Report of the Asia Team¹

1 Asia regional events since last Board Report:

- IWIRC at the INSOL Singapore Conference 2019: IWIRC had significant involvement and presence at the INSOL event in Singapore on 2-4 April 2019, including the following:
 - IWIRC Singapore hosted a lunch event, with Justice Belinda Ang of the Singapore Supreme Court as the guest-of-honour, as well as Julie Hertzberg (incoming President of INSOL International and the first woman to hold this position), Joan Janssen (Director- General, Legal Group, Ministry of Law) and Hon'ble James Peck (the former United States Bankruptcy Judge for the Southern District of New York). Regional Co-Chairs will seek similar opportunities for lunch events going forward.
 - Demonstrating the success of the Women on Panels initiative, 8 members (including AD, JC, JL and PS)
 were panellists at the conference.
 - IWIRC was also invited to attend the INSOL Members' Association Roundtable (further report below).
- IWIRC London/IWIRC Singapore event 9 May: Attendees from Hong Kong, London and Singapore took part in a seminar, which was held in Stevenson Harwood's London and Singapore offices connected via videoconference. The event was co-hosted by IWIRC. EF presented on developments in the Hong Kong restructuring landscape. Virtus Law partner Lauren Tang provided an overview of the first scheme of arrangement moratorium case in Singapore. Other speakers included Meiyen Tan, head of restructuring and insolvency at Oon & Bazul, and Sheila Ng, a partner at Rajah & Tann.

2 Supporting the 6 networks in Asia

- Hosting regular calls for the Co-Chairs of the 6 networks to share information and experiences, as well as calls within the Asia board. Last network chair call was 24 April 2019, with an Asia Board call on 22 May 2019. June call date is yet to be determined.
- We have continued to encourage more board members from the various Asian networks to consider attending the Leadership Summit this year. PS and EF will be attending from Asia. We have reminded the networks of the stipend which may be available.
- We have liaised with the various networks regarding their nominations for the various Founder Awards, and have submitted a nomination from the Asia regional board for the Melnik award on 22 May 2019.
- Hong Kong network JL, JC, AD and EF attend the HK network board meetings on a rotating basis as observers to keep communication channels open between local and international. IWIRC Hong

Kong held Spring Drinks on 11 April 2019 which was attended by 66 members. This was slightly lower than usual, which is likely to due to the proximity to other industry events (INSOL Singapore 2-4 April 2019 and Hong Kong Sevens 5 – 7 April 2019). IWIRC HK also held a very successful Speed Networking lunch event in May. Upcoming events for the Hong Kong Network include the annual Black Tie Charity Dinner on 19 June 2019 (which sold out in minutes of tables being available for sale), a Cantonese speaking event (Meditation and aromatherapy), a bowling event and a technical seminar with Judge Wang of the Shenzhen Court. The Hong Kong Network now has 206 members.

- **Singapore:** is looking to host a Black Tie event on 5 July 2019, and following its AGM is putting together a full calendar of events going forward. A further calendar of events will follow.
- Malaysia: held a forum on 8 April 2019 to discuss the corporate rescue mechanism one year on, that event was very well received. Malaysia is intending to hold a social event in May to profile IWIRC to a wider group of people (all members will attend and invite 1-2 non-members). Malaysia is intending to hold an event discussing careers in insolvency and restructuring and is currently liaising with one of the student representatives targeting a week in July to present to students. In addition, they are exploring a joint event with the Companies Commission in Malaysia in October, which event was proposed by the Companies Commission.
- India: Singapore and India hosted a joint event on 24 May 2019 the India network is doing a presentation on the IBC. On 24 January 2019 a conference "combating insolvency & bankruptcy intelligently a conversation with IBC experts" was held in New Delhi the conference was very well attended (about 100 attendees and a few became members of IWIRC).
- **Japan**: the Tokyo INSOL One Day Seminar is on Thursday 7 November. The organising committee has agreed the panel topics and is now looking to identify speakers and potentially an IWIRC run panel. Separately, they have penciled in Wednesday 6 November evening for an IWIRC Japan event.
- **PRC**: the Board has agreed to have regular calls to discuss the way forward for the Network the last meeting was 1-2 May.

3 Formation of new networks - Indonesia & Korea

- We continue to have discussions to see how we can help the launch of additional IWIRC networks regionally including by assistance in terms of the setup process, recruiting of members etc.
- Priority for 2019 is development of an Indonesia network. In Indonesia, the charge will be led by Debby Sulaiman, Partner at an Indonesian law firm, HHP and Nawal Nely of EY. The IWIRC Indonesia set up is still in progress and the necessary documents are with the notary to be signed.
- AW has been having discussions with relevant people in Korea with a view to establishing a network there. More details to follow when available.

4 Other Initiatives

Strengthening relationships with INSOL in Asia

IWIRC in Asia continues to liaise with INSOL following the connections made at the IWIRC Hong Kong Conference in November 2018. Specifically, PS met with Dr. Sonali Abeyratne, Technical Director of INSOL (based in Sri Lanka). Sonali is very keen to explore further co-operation between INSOL and IWIRC. In addition to speaking opportunities, she thinks there also several opportunities to co-operate on technical projects (eg best practices surveys) that INSOL has ongoing.

- Members of IWIRC Asia attended the Members Associations Roundtable on Tuesday 2 April during the INSOL conference. At this roundtable, the incoming president of INSOL, Julie Hertzberg noted that she wants to focus on increasing diversity within INSOL with a specific focus on gender diversity. An email was sent by EF to International following the roundtable with a number of follow up items for IWIRC following the meeting. A copy of that email is at Appendix 1.
- PS has been invited to join the INSOL Technical Committee for the Cape Town conference next year.
- Members of IWIRC from Asia, UK and the USA also attended a call with various members of INSOL on 3 May 2019. At this meeting we explored opportunities for the two organisations to further connect and support each other's initiatives. INSOL also agreed to share with IWIRC some information regarding its work and responsibility and to highlight some of the areas which INSOL thought IWIRC members could usefully be involved in, which was sent on 14 May 2019. A copy of that information is at Appendix 2.
- Action point for e-Board: to have an At-large board member with responsibility as liaison person (together with Shari) for developing relationship between IWIRC and INSOL / looking for initiatives where we can work together and promote our members.
- Women of the Year in Restructuring (WOYR) Asia Award we plan to run this again in 2019 (3 year sponsorship from Vannin Capital), and have in principle confirmation from GRR that IWIRC can host the award ceremony at the GRR Live Hong Kong conference on 16 October 2019, given IWIRC Asia has no intention to host a regional conference in Asia this year. A sub-committee has been formed (PS, AW, AD), and requests have been made to the Hong Kong Network for any additional people for the sub-committee.
- IAIR Gender Balance Survey IWIRC Asia was asked by the Official Receiver in Hong Kong (OR) for IWIRC's support with input to assist on responses to a survey on gender balance of insolvency practitioners in HK which she has been asked to complete by IAIR (International Association of Insolvency Regulators). We sought the assistance of the Hong Kong Network who sent the survey to their distribution list of members and friends, which was done on 12 April 2019. A short summary of the results is attached. The OR has offered to stay in touch with us on progress of the IAIR's initiatives in this area.
- Upcoming IWIRC Elections Nominations due 16 September 2019. The objective is to achieve representation across Asia and not just Hong Kong and Singapore if possible. CD is stepping down to focus on her role as Co-Chair of the Singapore network. Noting the emphasis on an open and transparent process or nominations, the Hong Kong Board [and other Boards] have been reminded to encourage their members to nominate (in addition to receiving the IWIRC International email). A number of candidates have shown an interest, and the Asia Board is intending to wait for any further nomination before speaking with the potential candidates, and making a recommendation to the eboard in this regard.
- Speakers Bureau We have now asked all the Asia networks to reach out to their members regarding the speaker's bureau and updating their information. This is still a work in progress and so follow up will be needed with most if not all of the Asia networks.
- Women on Panels Initiative EF to use role on MOC of INSOL Tokyo One Day seminar to suggest IWIRC members as speakers and we intend to do the same for INSOL Hong Kong via contacts on that MOC. PS to use role on INSOL Cape Town Technical Committee, and JC with TMA in Hong Kong to do the same.

- Technical Projects and papers members are encouraged to get involved in contributing to the current technical projects and special reports that are being developed. Currently we have over 20 projects and papers that are work in progress. (Current publications list attached)

 technical information of particular relevance to the small practitioner.

Women are underrepresented in both of these special interest groups and IWIRC could assist in promoting these special interest groups to its members.

The results are in for the IWIRC Hong Kong Gender Balance Survey!

In 2018, the International Association of Insolvency Regulators (IAIR) resolved to focus on the issue of gender balance after many jurisdictions around the world noted a relatively low number of women practicing as insolvency practitioners. The starting point has been to survey member organisations to paint a global picture and identify appropriate avenues for change. The Official Receiver's Office of the Hong Kong SAR (OR) is a member organisation of IAIR.

IWIRC Hong Kong recently worked with the OR to survey the professional community in Hong Kong. Of the survey respondents, there was an even mix of professionals from accounting/financial and legal backgrounds where 27% of the respondents held the experience of being a formal appointment taker.

Based on the perspective of both female (73%) and male (27%) respondents, the perceived key reasons in Hong Kong for an imbalance in the number of Panel A appointment takers (where only 30% are female) were: (1) industry bias (unconscious or otherwise), where men were perceived to be more likely to hold the type of senior leadership positions that would allow for them to become appointment takers; and (2) the broader consideration that in Hong Kong, due to inadequate maternity leave, gender pay gap and the pressures that women face to be the primary caregiver at home, that this may be in part due to a structural factors beyond the industry.

More respondents than not were of the view that there is an increasing number of female appointment takers (over the past 5 years). Most respondents recognised the initiatives of IWIRC in Hong Kong in supporting and promoting women in restructuring and insolvency as well as corporate/firm initiatives and other gender equity related discussion forums as contributing factors towards improvement of gender balance.

Some suggestions for positive initiatives that regulators and industry bodies may take to improve gender balance of insolvency practitioners include to: (1) provide for more flexibility in ways to gain appropriate qualifications; and (2) to encourage firms via policy initiatives to consider the issue of gender balance, including support of programs that support women both into the profession and through to senior levels.

It was a clear theme of the survey that, beyond the narrow focus of Panel A appointments, career progression in the restructuring and insolvency industry turns on relationship. IWIRC Hong Kong has many initiatives aimed at supporting and promoting women in the industry. A pillar of our mission is to provide varied opportunities for networking for all of our members and friends, women and men alike. We are also keen to profile our female members via speaking roles at conferences, by nominating them for industry awards and celebrating their successes on social media.

Dear Carrianne & Shari

We attended the Members Associations Roundtable on Tuesday 2 April during the INSOL conference.

The roundtable covered 3 subject areas and was generally an information sharing session between the different organisations present. It covered the following topics:

- i. Responding to the financial challenges of a declining market declining members, declining attendance at events, and new competitors.
- ii. Lobbying, communication and interaction with stakeholders regulators, governments, legislators etc
- iii. Corporate governance.

Some updates from INSOL:

- 1. INSOL are opening an Asia hub in Singapore to support the changing geographic footprint of its membership
- 2. During Julie Herztberg's 2 year term as president she wants to focus on increasing diversity within INSOL with a specific focus on gender diversity.
 - INSOL has 11,500 members but only 2,500 women (even though 30% of insolvency professionals are women). She wants INSOL to become more diverse and engage with more junior professionals. Her first focus is on gender diversity and having more women drafting INSOL publications, on INSOL panels and INSOL organising committees. Having the new Asia hub should help with more geographic footprint to offer more local content.
 - Pooja has separately been engaging with Sonali, Technical Director at INSOL as to how IWIRC and INSOL can work together on this. Pooja may be invited to join the INSOL Technical Committee for the CapeTown conference next year,
- 3. They plan to host similar roundtable meetings at INSOL conferences in the future.

Some observations:

 Many of the organisations are struggling with decreasing membership and engagement from members. A similar theme was wanting to focus on engaging more junior members of their local professions. We shared some learnings from the IWIRC Asian networks on how we had been able to do this by offering different types of events locally at low price point (e.g. Cantonese speaker events in Hong Kong). We also shared our view that the Asia WOYR (including having a high-powered external panel of women judges) had helped us to further raise our profile in Asia. • IWIRC seems to be ahead of the game in using social media to engage with its members

To-do items for IWIRC following the meeting:

- On the Corporate Governance topic Jason Baxter, INSOL, plans to work on some standard association rules / guidelines that developing member organisations can adopt. Pooja offered to share some intel from IWIRC in this regard including potentially customizing our Network Rules of Operation to create a ready template that could be used by any members' organisation in the R&I space.
- We met some members from Malaysian accountancy bodies we have already introduced them to IWIRC Malaysia Co-Chairs.
- We met Rene Bekker, COO of South African Restructuring and Insolvency Practitioners Association. She is interested about how IWIRC South Africa can be formed. Given INSOL will be hosted in Capetown in March 2020 this could be a great time to get this up and running aiming to host a launch event in Capetown in 2020. Shari could you please raise potential of South Africa network at the board meeting on 10 April and see whether there is interest for anyone on the international board to help with forming such a network. Eloise will connect Shari with Rene.
- Pooja to liaise with Jason on corporate governance project.

The first two networks are active networks, and continue to be successful with multiple events, a strong membership base and committed leadership. There have also been renewed efforts in the past months to rejuvenate the Montreal Network and we are hopeful that may come to fruition.

The Atlantic Canada network is no longer active, with no members or board. We are requesting that the Network be formally dissolved. Please advise us as to next steps for implementing the dissolution.

1. Ontario

- currently has 76 members, which is an increase over the past few years
- 14 member board with diversity in terms of seniority and background (legal, trustee, banking)
- very active network with events held approximately every two months
- Events held in 2019 to date include a mix of social/networking events and educational events (both soft skills and technical knowledge):
 - o AGM Networking event
 - o Workshop on presentation skills "How do you Show Up in the Boardroom"
 - Lunch and Learn: All about Trusts and Competing Priorities was very well attended
- Summer event planned for June Boat Cruise around Toronto Island is expected to be well-attended and typically includes a great mix of lawyers, trustees and bankers
- The board has discussed inviting judges to its holiday High Tea Event, which will be a first for Ontario as judges have not been invited in the past
- Ontario undertakes community service initiatives each year and this year is planning on including a community service initiative to help a local women's shelter as part of an event in the fall
- The board is still considering introducing a formal sponsorship program and options are being considered
- The board is considering options to increase membership outside of Toronto (including how to appeal to consumer practitioners) as the Toronto market is considered saturated

2. Western Canada

- approximately 64 members
- 11 member board
 - o good cross section of practitioners
- holds multiple events each year spread over three major cities in Western Canada:
 - Calgary
 - members-only free aerobics event hosted by one of the network's members who is a newly accredited fitness instructor was a success – very well attended
 - annual spa event took place in May, which was very well attended and is the most popular event every year

Vancouver

- April event De-Coding Hockey Wine and Cheese with guest speaker event for both members and non-members – event was well attended and well received, with positive feedback
- May event Self-care for the professional women discussion, which included discussion of a number of shorter articles on the importance of self-care. Articles were circulated prior to the event and attendees were encouraged to bring items to donate to charity serving women on the downtown eastside of Vancouver
- June event Pre-summer spa day
- August event Bowen Island meeting hosted by Dr. Janis Sarra (recent WOYR winner) – regional event for all IWIRC Canada members – save the date will be going out soon
- September event Summer Send off cocktail event, to coincide with IWIRC on the Vine
- Vancouver is planning to send a communication to members and new member targets including the Vancouver 2019 event schedule to highlight what is coming up and the benefits of IWIRC membership brochure – will be sent to targets by IWIRC Board members directly, rather than as a mass mailing

o Edmonton

- March event casual food and drinks, 12 attendees, which is a great turnout for Edmonton
- June event Educational Focus Event with Justice Donna Shelley
- Upcoming events include going to a beauty boutique where they make custom cosmetics, a fitness type event, a chocolate tasting event and a terrarium making workshop (concept would be to have fun making a bit of green in the winter)
- Edmonton is a smaller centre, so has fewer events and fewer members on the Board
 - Membership and Communications Director continues to work with the Edmonton Co-Chair to come up with ideas to increase engagement
- initiatives include:
 - sponsorship package has been rolled out it was a new model for the network, with three network-level sponsorships available and unlimited smaller ones (local only)
 - sponsorship ask was a success with three network level sponsors (one law firm, one accounting firm and one "other" service provider for restructuring/insolvency work) and several local sponsors, some of which have decided to sponsor in more than one city
 - welcome email to each new member from Network Chair with upcoming events listed and summary of value proposition
 - newsletter to members to highlight network members, their work and the sponsors – next newsletter will go out in late June
- IWIRC on the Vine
 - Save the date has gone out
 - Scheduled for September 27-29 in Kelowna, British Columbia (Okanagan Wine region)

- Sponsorship asks are in process currently have several sponsors
- Working on programming and events
- o Hotel rooms are now available at the discounted conference rate

3. Montreal

- essentially inactive for the last two+ years
 - challenges to this network include strong competition from other female networking groups, and the distinct culture and language issues in Quebec
- we have identified an IWIRC member in Montreal (Smaranda Mihalachi, Miller Thomson) who is interested and actively participating in an attempted revitalization of the Montreal Network
- the Montreal Network hosted a regional event (with the assistance and sponsorship of the Ontario Network, Western Canada Network and IWIRC International) on January 31
 - High Tea in advance of Canada's largest Canadian insolvency conference, which was held in Montreal
 - Approximately 37 attendees
 - great turn out from Ontario Network, Western Canada Network and a number of restructuring professionals from Montreal
 - great feedback received from all attendees, including those from Montreal
- Smaranda is planning another event in the next few months with the Montreal community to get the women together and elicit interest in IWIRC and the rejuvenation of the Montreal Network
- we are hopeful that, with the participation of Smaranda in Montreal and others that she hopes to enlist for assistance, we can gain traction leading to a successful relaunch of the Montreal Network

4. Atlantic Canada

- has essentially disappeared, with no board or registered members
- Former Chair, Leanne Salyzyn, has indicated it is just not feasible to have a network in her area
 - o only a handful of bankruptcy lawyers or Trustees
 - o spread out in small town and centres
 - o difficult to obtain support for an annual membership
- Consider formally dissolving this network

Sara and I will continue with calls/communication with the two active Canadian network chairs and with Smaranda. On our most recent call with the Western Canada Network Chair and the Ontario Network Chair, we discussed recent initiatives at the International level, including the website and soliciting feedback on same, the social media policy and diversity initiatives. We also discussed recent successes and challenges at both Networks to assist in event planning and continued assessment for improvement. Another call to discuss sponsorship is scheduled for June 5. A few things of note for International stemming from our most recent Canadian network chairs call:

i. It is a continued struggle to attract those from smaller firms and/or personal bankruptcy practitioners to join IWIRC. Suggestions are welcome in this area.

- a. We did mention the possible initiative to do various "tear sheets" each with benefits targeted to a particular group (eg. investment banks, personal bankruptcy practitioners), which the network chairs thought would be a good initiative. Other suggestions from our call include section(s) on the website targeted to different groups as well.
- ii. Website functionality A suggestion was to ensure that you can search members by where they practice vs. network, as the location of the member is not intuitive in some networks (eg. Rocky Mountain Group, Western Canada). This came up as there was need of a referral in Wyoming and it was difficult to search for this.

Sara and I are encouraging people to join in "virtual" events and attend regional conferences and events. Regional events continue to be a focus in Canada, and has led to the pace of and participation in regional events increasing. Examples include many virtual lunch and learns between the Ontario and Western Canada networks, cocktail receptions in advance of major Canadian insolvency conferences bringing together members from all Canadian networks, IWIRC on the Vine and the August Bowen Island meeting hosted by this year's WOYR award winner, Dr. Janis Sarra.

We continue to encourage our members to attend IWIRC International conferences, run for Board positions, nominate for awards, and generally find ways to engage more robustly with the larger IWIRC organization.

Re: U.S. Networks Status Report – May 2019 Update

Date: May 30, 2019

Below is a summary of our efforts since our last report on March 26, 2019:

2019 Spring Meeting

An in person chair meeting was held on April 10 at the Spring Conference. Representatives from thirteen U.S. IWIRC networks attended as well as representative from the Cayman Islands, Ontario, and Western Canada networks. The meeting included lively discussions regarding the Universal Goals (defined below), progress achieved on and lessons learned in connection with the goals. Breakout discussions were held regarding specific Universal Goals. Some of the takeaways from the breakout discussions were:

- 1) Promote the mantra to **Think IWIRC First**;
- 2) Open board meetings with one woman's short presentation on why hire me, which allows other board members to know exactly what they do;
- 3) Private LinkedIn/Face Book pages are an effective tool to communicate with members;
- 4) Membership only events, particularly with Judges, are great way to attract new members;
- 5) Reach out to established males at firms to find potential new women members and garner interest in IWIRC;
- 6) Highlight board members with names/photos in all communications;
- 7) Successful use of network logos with graphics (prior IWIRC approval required): and
- 8) Be aware of firms budgeting calendar get sponsorship requests in timely.

We also stressed the importance of having as many networks as possible attend the Leadership Summit in New Orleans. We suggested that if the network chair is unable to attend to send an active board member in her place.

Eventbrite Call

On May 15, 20019, Shari led an interactive call with network chairs and representatives regarding Eventbrite best practices and, in particular, an update on the use of "private" events. With the update, when setting up an event on Eventbrite, networks can now mark their events "private" so that they do not show up in any public Eventbrite searches, however, they will appear on the IWIRC website. Another benefit of the update is that the events can be refreshed quicker such that after the event is entered and goes live, it should show up on the website within 20 minutes rather than the 2-3 hours it was taking previously.

Annual Reports

Annual networks reports were due on April 16, 2019. With one exception, all U.S. Networks have submitted their reports (and the sole remaining report should be submitted next week).

New Networks

We have engaged in preliminary discussions with women who are interested in forming a San Antonio or San Antonio/Austin network. Additional discussions are scheduled to take place over the next few weeks with the hope of adding a new (46th) network in 2019.

Network Calls

Calls with all of the network chairs are typically held each quarter. The next network chair call is scheduled for June 18. After the 2018 Leadership Summit, each network was asked to select three of the eight universal goals (the "<u>Universal Goals</u>") to strive to achieve. The Universal Goals are broadly grouped into the following categories: communication, geography, membership, sponsorship, regional, leadership,

planning, and diversity of events. The June 18 call will focus on progress that networks have made on their universal goals and will spotlight networks regarding their successes achieved on the Universal Goals in order to offer tips, suggestions, and ideas to assist other networks with their goals.

Other Matters

We also participate on the Regional Programming calls in order to ensure consistency in connection with the messaging to the U.S. Networks. Melissa also participated on the May 8th call with IWIRC and INSOLV to explore synergies.
